Further, there is a possibility that these quarterly financial results along with the financial statements as of and for the year ended 31st March' 2017 may require adjustment before constituting the final Ind AS financial statements as of and for the year ending 31st March, 2018 due to changes in the financial reporting requirements arising from new or revised standards or interpretation issued by MCA or changes in the use of one or more optional exemptions from full retrospective application as permitted under Ind AS 101-First Time adoption of Indian Accounting Standards (Ind AS).
- 3. The Statutory Auditor have carried out a Limited Review of the Financial result for the quarter ended June 30, 2017.
- 4. The Company is engaged in one business segment i.e. Polymers & Compounds and it is primary segment.
